TERMS & CONDITIONS, ASSUMPTION OF RISK, AND LIABILITY WAIVER

Date/Location: April 25, 2026 Sports Illustrated Stadium

Race Organizer: NJ/NY Gotham Football Club LLC ("ORGANIZER")

Sponsor: Grüns Nutrition, Inc. ("SPONSOR")

By registering for and participating in this event (the "Event"), I acknowledge and agree to the following Terms and Conditions:

1. Eligibility and Participation

- I certify that I am physically fit and have sufficiently trained for participation in this Event.
- I acknowledge that I should consult a physician prior to participation if I have any medical condition or concern.
- Participants under the age of 18 must have a parent or legal guardian execute this agreement. I understand that under New Jersey law, waivers signed on behalf of minors may not be fully enforceable.

2. Assumption of Risk

I understand that participation in a road race involves inherent and significant risks, including but not limited to:

- Personal injury, illness, permanent disability, or death
- Slips, trips, and falls
- Collisions with other participants, vehicles, pedestrians, or fixed objects
- Weather conditions including heat, cold, humidity, rain, or lightning
- Road hazards and uneven surfaces
- Negligent acts or omissions of myself or others

I knowingly and voluntarily assume all such risks, whether known or unknown, including risks arising from the ordinary negligence of the Released Parties, to the fullest extent permitted under New Jersey law.

3. Waiver and Release of Liability

To the fullest extent permitted by the laws of the State of New Jersey, I release, waive, and discharge and covenant not to sue ORGANIZER, SPONSOR, and all related parties (the "Released Parties") from any and all claims, including those arising from ordinary negligence, but excluding gross negligence, reckless conduct, or intentional misconduct.

4. Indemnification

I agree to indemnify and hold harmless the Released Parties from any claims arising out of my participation in the Event.

5. Medical Authorization

I consent to emergency medical treatment and accept responsibility for associated costs.

6. Event Rules and Conduct

I agree to follow all Event rules and understand I may be removed for safety reasons.

7. Weather and Event Modifications

The Event may be modified or canceled for safety reasons.

8. Photography and Media Release

I grant permission for use of my image and likeness for promotional purposes.

9. Data and Privacy

I consent to use of my information for Event administration and for ORGANIZER and/or SPONSOR to contact me with promotional and or other communications.

10. Governing Law

This Agreement is governed by the laws of the State of New Jersey.

11. Severability

If any provision is invalid, the remainder remains in effect.
